

At times when work is taken for a period less than a week because of closure of the school etc. rates would be calculated for a day and payment made accordingly.
- 8. Arbitration: In case of any dispute between the contractor and the KV arising cut of or in relation to the agreement, the dispute shall be referred to a sole Arbitrator to be appointed by the Kendriya Vidyalaya and the decision of such Arbitrator shall be conclusive and binding on both the parties. The arbitration shall be governed by the provisions of Indian Arbitration Act, 1940.
- 9. Jurisdiction: The courts at the station will have jurisdiction over all legal disputes under this agreement.
